

## Stormont House School Cover Supervisor

Stormont House School is an exceptional and widely respected special school whose students achieve from Entry Level up to GCSE. We became one of the first outstanding schools in the country in 2005 and have improved at each of the 4 full inspections since then (most recently in 2024). We work with other schools as a National Support School and as a lead school within the Hackney Teaching & Schools' Alliance.

The Cover Supervisor will be responsible for delivering prepared lessons to whole classes (usually 12 students) when their regular teacher is absent. You will also have some other duties which will fully involve you in the life of the school. When you are not required for cover, you will be involved in delivering and supporting interventions in or out of the classroom; provide additional class-based support in the absence of teaching assistants and support the exams team in invigilating as required. You will have worked in a school or similar setting before, have a genuine liking for young people and be able to set clear boundaries for their behaviour so that they focus on learning.

We offer a diverse and vibrant curriculum, which is tailored to meet students' needs by exciting, supporting and challenging them. We expect our students to make the best progress possible; socially, emotionally and academically. Intervention Support staff work with students who may have experienced difficulties in one or more of these areas.

We are now looking to appoint a skilled and passionate colleague who will further enhance the intervention team, working with more individual students, small groups, parents and staff. We are looking for someone who puts young people first, is caring, proactive, imaginative, and supportive.

We are unblinkingly focused on continual improvement, and this position plays a vital part in leading us towards our vision of 'Achievement for All in a Unique World-Class School'. We serve a richly diverse community and welcome applications from all sections of the community, regardless of gender, race, religion, disability, sexual orientation, or age. Applicants will need to have considerable school-based experience. Due to high levels of interest in this position and the value we place on selecting the right person please be clear in your statement why you wish to be appointed as a Cover Supervisor at this school.

We are committed to safeguarding our children: in addition to an enhanced DBS check, one of your referees MUST be your current or most recent Headteacher (or equivalent), and references will be taken prior to interview. If you are currently employed through an agency, you must put your agency as a referee, and the Headteacher (or equivalent) of the school you are currently or most frequently deployed in. If you would like you can also provide a third referee. In line with Keeping Children Safe in Education (KCSIE) guidance, we will also conduct an online search about any shortlisted candidates as part of our due diligence to identify any matters that might relate directly to our legal duty to meet safeguarding duties.
